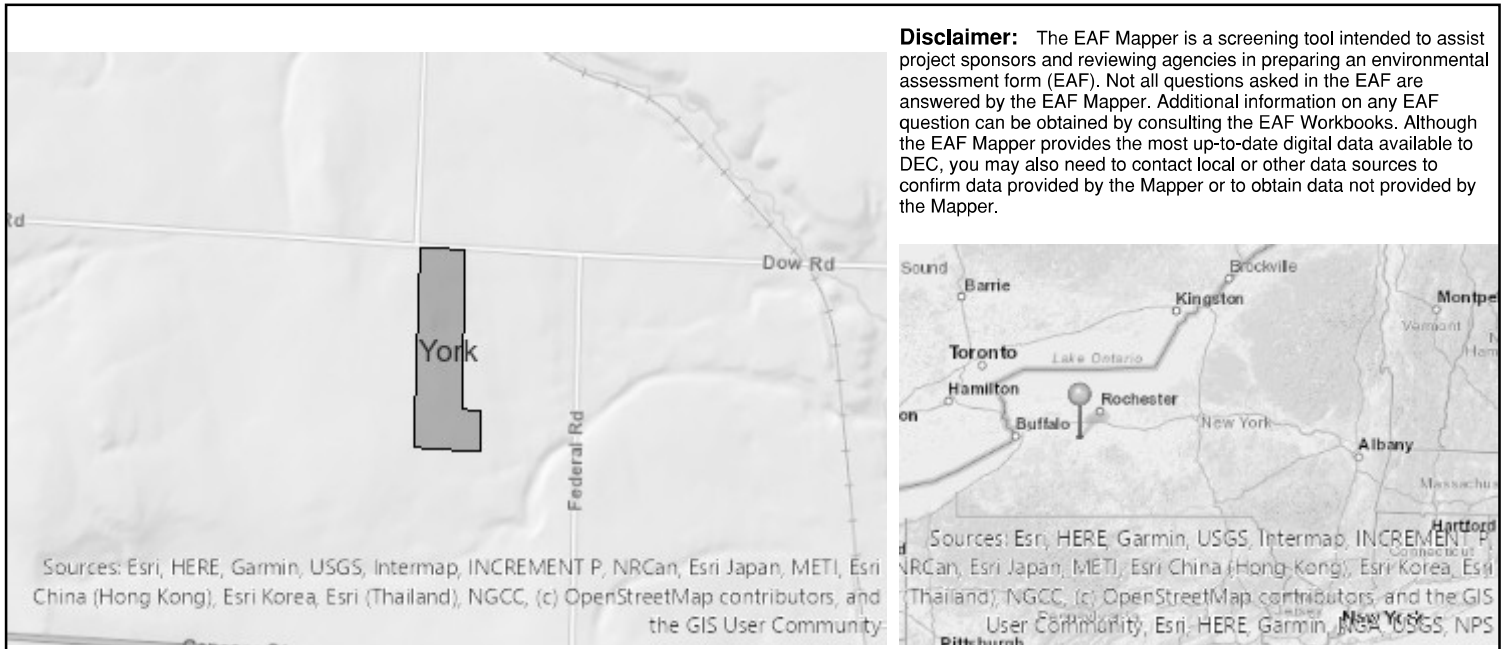

This site is at the present location of a solar turbine gas compressor station. Formerly, the site was an active conventional gas turbine station, which was demolished and buried. Limited sampling of current equipment did not show PCB contamination. A Phase II Investigation consisting of 9 boreholes and 43 soil samples revealed trace levels of PCBs (Aroclor 1254) at less than 1 ppm in some of the soil samples. Since the site was covered with soil after the demolition was completed, there is some uncertainty as to the exact locations of the potential waste disposal areas. The PRP has agreed to submit a workplan with detailed drawings to better assess the sampling locations. Limited soil sampling was done by the PRP at the site in May and July of 1995. A report which contains the analytical results was prepared in 1996.
